Further work in this area: project on airline pricing focusing on the impact of entry behaviors as a deterrent to higher prices in the airline industry. This will lead to a paper for a public

policy or economics journal. This work extends the concepts that formed the theory for the working paper listed above, which is more empirical and pitched to an audience of serious business practitioners and policy professionals as well as economists.

- 2. A project on the impact of external shocks and restructuring on competition in the global airline industry is envisioned. This will draw on previous work on Air New Zealand in the post-9/11 environment. Work awaiting an opportunity to conduct the research in New Zealand.
- 3. Public Science and Industry Collaborations as they affect Global Competitiveness An article is contemplated on the collaboration between a state-owned science organization and a major export company in the NZ Kiwifruit industry. The research question is what dimensions of the collaboration provide a basis for global competitiveness of both the NZ industry and the export company (which is owned by the growers of kiwifruit). Also to be developed: the benefits and costs of a single-desk-exporter for a nationally important industry versus a more purely free market structure. Work awaiting an opportunity to conduct research in New Zealand.
